EXHIBIT REQUIREMENTS

Our purpose is to hang an exhibit that best presents and promotes your work, so please adhere to these requirements.

1. Each Museum Artist may submit **ONE** piece. The work must have been created in the last year.
2. All mediums are acceptable, including assemblages.  
\*Sculptors, please contact the museum regarding space availability.
3. **Work may not have been exhibited at TAM before.** The Museum reserves the right to screen entries.
4. Artists may not remove work prior to the end of the exhibit. No exceptions.
5. All work must be original. Reference photos must be the copyright property of the artist.
6. Artwork must be properly framed or gallery-wrapped and wired for hanging (please no sawtooth hangers).
7. Maximum vertical size (including frame and mat) is 36”  
Maximum horizontal size (including frame and mat) is 42”
8. Complete labels (see page 2) in full and mark with either a price or NFS. The museum retains a 25% commission on sold artwork. Artists who sell artwork will receive their compensation after the exhibit has concluded. Please attach one label to the back of each piece (upper left-hand corner when looking at the back), and present the other label at check-in on **Friday, September 4 or Saturday, September 5, 2020.**
9. The Studio Gallery has limited hanging space. When necessary, the Exhibits Committee reserves the right to limit the number of paintings hung in any exhibit, but will do so fairly, providing each Museum Artist the opportunity to exhibit work during the year.

DELIVERY AND PICK-UP OF ARTWORK

1. **Deliver art to the Museum between 10 am – 5 pm on Friday, September 4 or Saturday, September 5 from 10 am – 4 pm.** If you cannot deliver your work at that time, please make arrangements to have someone else deliver for you.
2. **Pick-up artwork on Wednesday, November 11, 2020 between 10 am – 6 pm.**  
\* Artists relinquish all rights and interest in artwork not picked up within 45 days.

OPENING

In the interest of protecting public health, TAM will not be hosting any exhibit opening receptions for the time being. We are continually monitoring the COVID-19 situation and look forward to a time when such events are permissible once again.
